The award is presented for noteworthy service with exceptional character on behalf of youth to registered Scouting volunteers.

**QUALIFICATIONS:**

- 1] The nominee must be a registered adult Scouter (any capacity).
- 2] Service to youth must be exemplary, above and beyond the call of duty.
- 3] Service to youth outside Scouting is considered as well as service in Scouting.
- 4] The nominee must be over the age of 21.
- 5] Nominations will not be considered for professional Scouters within five years of leaving the profession.
- 6] Nominations cannot be considered for posthumous awards.

**PLEASE FOLLOW THESE INSTRUCTIONS IN MAKING A NOMINATION:**

- 1] The person you are nominating **MUST NOT BE TOLD THEY ARE BEING CONSIDERED.**
- 2] **EVERY SECTION OF THE NOMINATION FORM MUST BE FILLED IN.** For example: if the nominee is single, then fill in the space "Name of Spouse" with "Not Married".
- 3] All factual information **MUST BE WRITTEN ON THE NOMINATION FORM.**
- 4] Give as many dates and details as possible. If more space is needed, attach a page with the same headings as shown on the form.

You are welcome to attach "letters of recommendation or endorsement: but any factual information in the letters **MUST** be transferred to the Nomination Form before it is turned in to the **Council Service Center, 1410 E. Seventh Street, Charlotte, North Carolina, 28204-2488.** Nominees not selected this year **ARE NOT AUTOMATICALLY** considered the next year. A nomination must be submitted each selection year.
